1. Introduction

1.1. General

1.2. Service descriptions

1.2.1. Insight Control

With ASSA ABLOY Insight Control you can in real-time monitor and control your ASSA ABLOY doors and receive personal notifications of important events.

Insight Control enables you to:

- Monitor door and loading bay activity and receive in app notifications of critical events
- Remotely open/close your industrial doors
- Activate and de-active the door control units
- Subscribe to email notifications such as doors standing open longer than an expected timeperiod as well as equipment errors and alerts such as obstruction detection and vehicles departing a loading bay prior to loading completion.

1.2.2. Insight Mobile

With ASSA ABLOY Insight Mobile you can remotely open and close your doors directly from your smartphone and easily administrate who has access to the app.

Insight Mobile enables you to:

- Conveniently open and close your ASSA ABLOY industrial doors via your smartphone
- Distribute and revoke access to your doors directly in the app
- View door position in real-time
- Receive notifications of unexpected events in the app or via email

With ASSA ABLOY Insight Planner you can access and monitor your equipment heath condition and overview your service business with ASSA ABLOY.

Insight Planner enables you to:
